

Official Rules for the Veer Spring 2009 Draw

1. ELIGIBILITY. To be eligible to enter the Veer Spring 2009 Drawing (hereinafter, "Draw"), at the time of entry you must be (i) a legal resident of the 50 United States or Canada (excluding Quebec), and (ii) above the age of majority in your state, jurisdiction or province/territory of residence. 5. PERSONAL DATA.
